



2019 CHRISTMAS DAY SNOWFALL PROMOTION
- GOVERNING RULES -

- 1.] Any individual who purchases jewelry, gift items or gift certificates (excluding repairs) valued at \$25.00 or more at Windsor Jewelry between November 7th, 2019 up to and including December 18th, 2019 is entitled to 100% refund on said purchase(s) if it snows 3" or more on Christmas Day, December 25th, 2019 between the hours of 12:01A.M. and 11:59 P.M. **THIS REFUND DOES NOT INCLUDE SALES TAX.**
- 2.] All merchandise purchased during the special "Snowfall" promotion must be paid in full by closing on December 18th, 2019 in order to be eligible for 100% refund in the event of "snow" as defined in Rule #1. No promotional trade or gift certificates can be used during this promotion.
- 3.] Any item(s) purchased in the special "Snowfall" promotion and not paid in full by December 18th, 2019 at closing shall be considered "layaway" and are not eligible for refund as defined in Rule #1.
- 4.] The official snowfall accumulation will be measured and determined at the Indianapolis International Airport, as determined by the meteorological services company, Weather Command.
- 5.] The customer must sign a waiver agreeing to **NO REFUNDS** or returns of items purchased during this special promotion. Once the merchandise is purchased, the sale is final. However, the merchandise may be exchanged for other merchandise of equal or greater value before January 12th, 2020.
- 6.] In the event of a Christmas Day snowfall as defined in Rule #1 and measured pursuant to Rule #4, claims could take up to ninety (90) days to make payment from the end of the promotion date due to the insurance company's policy language and payment processing.
- 7.] In order to receive a refund for the "Snowfall" promotion, the following procedures must be strictly followed:
 - A.] The original sales receipt must be presented along with a government issued ID Card.
 - B.] A refund will be given only to the original purchaser.
 - C.] Refund amount will not include any sales tax amount paid.
- 8.] Please be advised that Windsor Jewelry will not be in a position to confirm that the amount of snowfall occurred until a minimum of seven (7) business days after the insured date.
- 9.] All refunds must be claimed by 4/1/2020. It is the qualified Customer's responsibility to claim their refund by the above date. No refunds will be issued after that date.
- 10.] Windsor Jewelry reserves the right to stop this promotion at any time, without notice, and honor those purchases made prior to the cancellation of the promotion.
- 11.] No purchase necessary. One of the "no purchase necessary" entries will have the chance to win a prize valued at \$200.00. All official entry forms must be received no later than December 18th, 2019. The official entry form must contain a first and last name, telephone number, complete mailing address, zip code and email address. Incomplete entries or those containing incorrect information will be voided.
